Handicap & Scratch Divisions Rules and Regulations

1. ELIGIBILITY: Entrants must be a certified member of the Mercer Burlington BA. **Certification cards must be shown prior to bowling, NO EXCEPTIONS.** Unmarried grade or high school students who have not reached age 18 must have written consent from a parent or guardian.
2. Late bowlers start in frame being bowled – no score for previous missed frame(s).
3. All entries should be on the official entry blank. This is to be used as official line-up.
4. After entries that have been received and the dates requested and approved by the tournament director, and are not refused by the team or individual entrant prior to the schedule, no fees shall be refunded.
5. AVERAGES: Highest 2010-2011 USBC certified average in the Final Average Book. If none, a bowler must have average from current league with verification as of Feb 1st, 2012. If no average bowler will bowl scratch (215) average.
6. The Ten Pin Rule (319a) will not be in effect.
7. Each bowler is responsible to verify the accuracy of their average. Those bowlers who fail to correct any average mistake are subject to disqualification under USBC Rule 319a(3).
8. Individuals may bowl on more than one team, but must change one member in order to cash more than once.
9. The first time an event is bowled it will count towards a bowlers' All-Events score (All event bowlers must bowl all three events.)
10. All events must be paid at the time application is submitted.
11. In case of a tie in any event of 1st place, co-champions will be declared.
12. Any complaints or errors must be made within 48 hours. The decision of the Tournament Committee will be final.
13. Automatic scoring systems are used. Tournament management has the discretionary right to determine if an irretrievable frame or game should be re-bowled.
14. Handicap:
 - Team – 80% of 860 (860 is the cap for Team in the Handicap division.)
 - Doubles – 80% of 430 (430 is the cap for Doubles in the Handicap division.)
 - Singles – 80% of 215 (215 is the cap for Singles in the Handicap division.)
 - All-Events "A" – 190 and above Scratch
 - All-Events "B" – 189 and below Scratch
15. Scratch:
 - Doubles- 430 & above
 - Singles – 215 & above
16. The Tournament Manager reserves the right to cancel any Squad with less than six prepaid entries and re-assign the entrants to an alternate squad.
17. A non-refundable \$25.00 deposit with team captains name and address must be forwarded with entry form.
PLEASE DO NOT SEND CASH THROUGH THE MAIL.
18. The Tournament Committee reserves all rights and any USBC Rule not covered in these rules will prevail throughout this tournament.
19. No prize money will be paid out until Average Verification form is filled out.
